## **ULSTER SAVINGS CERTIFICATES**

## Ulster Savings Certificates (Eighteenth Issue) Regulations 1978

Made 13th December 1978 Coming into operation . 29th January 1979

The Department(a) of Finance in exercise of the powers conferred upon it by Section 15(1) of the Exchequer and Financial Provisions Act (Northern Ireland) 1950(b) and of all other powers enabling it in that behalf hereby makes the following regulations:—

- 1.—(1) These regulations may be cited as the Ulster Savings Certificates (Eighteenth Issue) Regulations 1978 and shall be construed as one with the Ulster Savings Certificates Regulations 1962 to 1978(c) and those regulations and these regulations may be cited together as the Ulster Savings Certificates Regulations 1962 to 1978.
  - (2) These regulations shall come into operation on 29th January 1979.
- 2.—(1) For paragraphs 1 and 2 of Schedule 2 to the Ulster Savings Certificates Regulations 1962(d) there shall be substituted the following paragraphs:--
  - "1. The purchase price of a unit certificate shall be ten pounds.
  - 2. The amount repayable in respect of a unit certificate shall be as follows:—

Within one year from date of purchase ten pounds.

On and after the termination of one year from the date of purchase ten pounds and fifty pence with a further addition of twenty five pence in respect of each successive completed period of four months during the second year of currency and thirty three pence in respect of each successive completed period of four months during the third year of currency and forty two pence in respect of each successive completed period of four months during the fourth year of currency and fifty pence in respect of each successive completed period of four months during the fifth year of currency."

- (2) Certificates to which this Regulation applies shall be known and inscribed "18th Issue".
- (3) This Regulation applies only to certificates of the Eighteenth Issue issued on or after the 29th January 1979.

- 3. Schedule 3 to the Ulster Savings Certificates Regulations 1962(e) (which Schedule prescribes the maximum number of certificates which may be held), shall be further amended by substituting for paragraphs (i) (j) and (k) the following paragraphs:—
  - "(i) three thousand, in the case of certificates issued between the 17th June 1974 and the 12th December 1976 and between the 1st April 1977 and the 28th January 1979 (known as the Fourteenth Issue); and
  - (j) seventy, in the case of certificates issued on or after 2nd June 1975 under the name Ulster Savings Certificates Index Linked Retirement Issue; and
  - (k) three hundred, in the case of certificates issued between 12th December 1976 and 31st March 1977 (known as the Sixteenth Issue); and
  - (1) one hundred and fifty, in the case of certificates issued on or after 29th January 1979 (known as the Eighteenth Issue)".
- 4. The Ulster Savings Certificates (Fourteenth Issue) (Amendment) Regulations 1977(f) are hereby revoked.

## EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These Regulations prescribe the terms governing the issue of Ulster Savings Certificates of the Eighteenth Issue which is to commence on 29th January 1979 and also set a maximum holding which a person may have in addition to the permitted maxima of Ulster Savings Certificates of other Issues. They also revoke the provision of a minimum purchase of 5 units at any one time made after 1st April 1977 of certificates of the Fourteenth Issue as this is no longer necessary.
