**Pigs (Feed Price Allowance) (Amendment) Scheme
(Northern Ireland) 1978**

Made 14th February 1978

Coming into operation 1st April 1978

The Department of Agriculture, in exercise of the powers conferred by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) as amended by the Agriculture (Temporary Assistance) (Amendment) Act (Northern Ireland) 1957(b) and now vested in it(c) and of every other power enabling it in that behalf and with the approval of the Department(d) of Finance, hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Pigs (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1978 and shall come into operation on 1st April 1978.

Amendment of Pigs (Feed Price Allowance) Scheme (Northern Ireland) 1972

2. The Pigs (Feed Price Allowance) Scheme (Northern Ireland) 1972(e) is hereby amended as follows:

In Article 4 for "£6 million" there shall be substituted "£8 million" and for "31st March 1978" there shall be substituted "31st March 1979".

EXPLANATORY NOTE

(This note is not part of the Scheme but is intended to indicate its general purport.)

This Scheme amends the Pigs (Feed Price Allowance) Scheme (Northern Ireland) 1972 by increasing from £6 million to £8 million the maximum amount which can be paid in total under the Pigs, Eggs and Poultry Feed Price Allowance Schemes and by extending by 1 year the period in which this amount can be spent to 31st March 1979.
