**The Poultry (Feed Price Allowance) (Amendment) Scheme
(Northern Ireland) 1978**

Made 14th February 1978

Coming into operation 1st April 1978

The Department of Agriculture in exercise of the powers conferred on it by Section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) as amended by the Agriculture (Temporary Assistance) (Amendment) Act (Northern Ireland) 1957(b) and now vested in it(c) and of every other power enabling it in that behalf, and with the approval of the Department(d) of Finance, hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Poultry (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1978 and shall come into operation on 1st April 1978.

2. The Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971(e) as amended by the Poultry (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1976(f) and the Poultry (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1977(g) is hereby further amended as follows:—

In Article 3 for “£6 million” there shall be substituted “£8 million” and for “31st March 1978” there shall be substituted “31st March 1979”.

EXPLANATORY NOTE

(This note is not part of the Scheme but is intended to indicate its general purport.)

This Scheme further amends the Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971. It specifies the maximum amount which can be paid in total under the poultry, eggs and pigs feed price allowance schemes to 31st March 1979.
