## HOUSING

**Option Mortgage (Rates of Interest) Order (Northern Ireland) 1978**

*Made* . . . . . 23rd March 1978

*Coming into operation* . . . . . 1st April 1978

*To be laid before Parliament under paragraph 3(3) of  
Schedule 1 to the Northern Ireland Act 1974*

The Department of the Environment, in exercise of the powers conferred on it by Article 11 of the Housing (Northern Ireland) Order 1978(a), hereby makes the following Order:—

*Citation and commencement*

1. This Order may be cited as the Option Mortgage (Rates of Interest) Order (Northern Ireland) 1978 and shall come into operation on 1st April 1978.

*Interpretation*

2. In this Order “the Order” means the Housing (Northern Ireland) Order 1978.

*Calculation of interest*

3. Where, for the purposes of Article 11 of the Order, the rate of interest which would have been applicable under the repayment contract but for the taking effect of an option notice in respect of the loan falls within one of the limits in column (1) of the Schedule then:

- (a) where all the periodical payments by the borrowers to the lender in connection with any loan, so far as they are in respect of interest, are in respect of interest on the whole of the capital sum lent, or where any part of such periodical payment, so far as it is in respect of interest, is in respect of interest on a part of the capital outstanding of which, under the repayment contract, no repayment is required to be made by that periodical payment then in relation to any such periodical payment or, as the case may be, any such part of a periodical payment, the rate of interest for the purposes of Article 11(1)(b) of the Order is to be that specified in column (3) of the Schedule opposite that limit; and
- (b) for all other repayment contracts the rate of interest for the purposes of Article 11(1)(b) of the Order is to be that specified in column (2) of the Schedule opposite that limit.

## EXPLANATORY NOTE

*(This note is not part of the Order but is intended to indicate its general purport.)*

This Order specifies the rates of interest to be used in calculating option mortgage subsidy payable under the Housing (Northern Ireland) Order 1978.

The percentages in column (2) of the Schedule apply in the case of annuity mortgages and fixed instalment mortgages and the percentages in column (3) of the Schedule apply in the case of endowment mortgages and standing mortgages.
