Police Cadets (Amendment) Regulations (Northern Ireland) 1978

Made 30th March 1978

Coming into operation 1st May 1978

To be laid before Parliament

The Secretary of State, in pursuance of section 10 of the Police Act (Northern Ireland) 1970(a), read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and after consulting the Police Council for the United Kingdom and, in accordance with section 34(2) of the said Act of 1970, the Police Authority for Northern Ireland and the Police Association for Northern Ireland, hereby, with the concurrence of the Minister for the Civil Service(c), makes the following regulations:

Citation, commencement and effect

1.—(1) These regulations may be cited as the Police Cadets (Amendment) Regulations (Northern Ireland) 1978.

(2) These regulations shall come into operation on 1st May 1978 and shall have effect—

(a) for the purposes of regulation 3 as from 1st September 1977;

(b) for the purposes of regulation 4 as from 1st May 1978.

Interpretation

2. In these regulations any reference to the principal regulations is a reference to the Police Cadets Regulations (Northern Ireland) 1970(d).

Pay scales

3. For the Table in Schedule 1 to the principal regulations (scale of pay) there shall be substituted the following Table:

Board and lodging charges

4. In Schedule 2 to the principal regulations (charge for board and lodgings) for the reference to "£180" there shall be substituted a reference to "£198" and for the reference to "£193" there shall be substituted a reference to "£211".

EXPLANATORY NOTE

*(This note is not part of the regulations but is intended to indicate
their general purport.)*

These regulations amend the Police Cadets Regulations (Northern Ireland) 1970.

Regulation 3 increases the pay of police cadets from 1st September 1977 and regulation 4 increases from 1st May 1978 the charge payable by cadets for board and lodging provided by the Police Authority.

Retrospective effect is authorised by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
