# ROAD TRAFFIC AND VEHICLES

# One-Way Traffic (Newtownards) Order (Northern Ireland) 1979

Made . . . . . . . 8th May 1979

The Department of the Environment in exercise of the powers conferred on it by section 19 of the Road Traffic Act (Northern Ireland) 1970(a) and of every other power enabling it in that behalf, hereby makes the following Order.

#### Citation and commencement

1. This order may be cited as the One-Way Traffic (Newtownards) Order (Northern Ireland) 1979 and shall come into operation on 11th June 1979.

#### Revocation

2. The Bye-laws in respect of one-way traffic specified in Schedule 2 are hereby revoked.

### Prohibition

3. No person shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit any vehicle to proceed on the roads or any of the lengths or road specified in column 1 of Schedule 1 in a direction other than that specified in relation to that road or length of road in column 2.

Any person who acts in contravention of this Order shall be liable on summary conviction to a fine of £100.
