# ROAD TRAFFIC AND VEHICLES

# One-Way Traffic (Ballymena) Order (Northern Ireland) 1979

Made . . . . . 3rd October 1979

Coming into operation . . . . . . . . . . . 12th November 1979

The Department of the Environment in exercise of the powers conferred on it by section 19 of the Road Traffic Act (Northern Ireland) 1970(a) and of every other power enabling it in that behalf, hereby makes the following order:—

# Citation and commencement

1. This order may be cited as the One-Way Traffic (Ballymena) Order (Northern Ireland) 1979 and shall come into operation on 12th November 1979.

#### Revocation

2. The bye-laws in respect of one-way traffic specified in schedule 1 are hereby revoked.

#### Prohibition

3. No person shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit any vehicle to proceed in the roads or in any of the lengths of road specified in column 1 of schedule 2 in a direction other than that specified in relation to those roads or lengths of road in column 2.

# EXPLANATORY NOTE

This Order gives legal effect to one-way traffic systems in the town of Ballymena.

Traffic signs indicating the effect of the order have been erected on the roads.

Any person who acts in contravention of the order shall be guilty of an offence and is liable on summary conviction to fine not exceeding £100.
