## REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES

## Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1979

*Made* . . . . . 22nd February 1979  
*Coming into operation* . . . . . 1st April 1979  
*To be laid before Parliament under paragraph 3(3) of  
 Schedule 1 to the Northern Ireland Act 1974*

In exercise of the powers conferred upon me by section 1 of the Registration of Births, Deaths and Marriages (Fees, etc.) Act (Northern Ireland) 1955(a) as modified by section 40 of, and Paragraph 4 of Schedule 5 to, the Northern Ireland Constitution Act 1973(b), Article 47 of the Births and Deaths Registration (Northern Ireland) Order 1976(c) and Article 15 of the Financial Provisions (Northern Ireland) Order 1976(d) I hereby make the following Order:

*Citation and commencement*

1. This Order may be cited as the Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1979 and shall come into operation on 1st April 1979.

*Fees payable*

2. The amounts of the fees payable under the several enactments set forth in the second column of the Schedule in respect of the services described in the third column thereof shall be those specified respectively in the fourth column thereof.

*Revocation of Order*

3. The Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1976(e) is hereby revoked.
