The Registrar, in exercise of the powers conferred upon him by section 123(1) of the Building Societies Act (Northern Ireland) 1967(a), and of every other power enabling him in that behalf, and with the consent of the Depart $ment(\mathbf{b})$ of Commerce, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1979 and shall come into operation on 1st May 1979.

Revocation

2. The Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1978(c) are hereby revoked.

Amendment of fees

3. For Schedule 2 to the Building Societies (Forms and Fees) Regulations (Northern Ireland) 1968(d) (as substituted by the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1978) there shall be substituted the following Schedule:

They supersede the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1978.
