Teachers' Salaries (Amendment No. 3) Regulations (Northern Ireland) 1980

The Department(a) of Education, in exercise of the powers conferred on it by Articles 57(1) and 125(1) of the Education and Libraries (Northern Ireland) Order 1972(b) and by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(c) and of every other power enabling it in that behalf, after consultation with the Department(a) of Finance, hereby makes the following regulations:

PART I

GENERAL

Citation and commencement

- 1.—(1) These regulations may be cited as the Teachers' Salaries (Amendment No. 3) Regulations (Northern Ireland) 1980.
- (2) These regulations shall come into operation on 29th September 1980 and shall have effect—
 - (a) for the purposes of Part II thereof, on and from 1st April 1980;
 - (b) for the purposes of Part III thereof, on and from 1st September 1980.

Amendment of regulations

2. The Teachers' Salaries Regulations (Northern Ireland) 1978(d) are hereby amended in accordance with the following provisions of these regulations and references in these regulations to a numbered regulation or a numbered schedule, in the absence of a provision to the contrary, are references to the regulation or schedule so numbered in the Teachers' Salaries Regulations (Northern Ireland) 1978.

PART II

AMENDMENTS HAVING EFFECT ON AND FROM 1st APRIL 1980

Salary scales

3. For Schedule 1 there shall be substituted the Schedule set out in Annex A to these regulations.

Principals: additional provisions relating to scales and allowances

Peripatetic and supply teachers: salaries

5. In regulation 23(2) for "£480" there shall be substituted "£543".

Allowance for teachers of handicapped pupils

6. In regulation 25(1) and (2) for "£480" there shall be substituted "£543".

Unqualified teachers

- 7.—(1) In regulation 33 for "£2,673" there shall be substituted "£3,018".
- (2) In regulation 34(1) for "£3,519" there shall be substituted "£3,972".

Part-time teachers: payment

8. In regulation 36(1) for the rates per hour of "£4.50", "£3.73" and "£3.08" there shall be substituted "£5.08", "£4.21" and "£3.48" respectively.

Re-assessment of salary following incorrect placing

9. In regulation 37(1) for "1st January 1980" there shall be substituted "1st April 1980".

Transfer to salary scales at 1st April 1980

- 10. In Part I of Schedule 2-
- (1) for "1st January 1980" where this occurs there shall be substituted "1st April 1980":
- (2) for "31st December 1979" where this occurs there shall be substituted "31st March 1980";

Provisions affecting salary placings

18. In regulation 36(1) for the rates per hour of "£5.08", "£4.21" and "£3.48" there shall be substituted "£5.53", "£4.58" and "£3.79" respectively.

Re-assessment of salary following incorrect placing

19. In regulation 37(1) for "1st April 1980" there shall be substituted "1st September 1980".

Transfer to salary scales at 1st September 1980

- 20. In Part I of Schedule 2-
- (1) for "1st April 1980" where this occurs there shall be substituted "1st September 1980";
- (2) for "31st March 1980" where this occurs there shall be substituted "31st August 1980";
 - (3) in paragraph 2(a) for "£7,191" there shall be substituted "£7,887";
 - (4) in paragraph 2(b) for "£7,731" there shall be substituted "£8,481".

Provisions affecting salary placings

- 21. In Part II of Schedule 2-
- (1) with the exception of paragraph 3A, for "1st April 1980" where this occurs there shall be substituted "1st September 1980";
 - (2) in paragraphs 9(2) and (3) for "£543" there shall be substituted "£594".

Incremental credit on scale 1

- 22. In paragraph 4 of Schedule 5-
- (1) for "£96" there shall be substituted "£102";
- (2) for "£165" there shall be substituted "£183";
- (3) for "£186" there shall be substituted "£204".

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations introduce revised scales of salary from 1st April 1980 (Annex A) and from 1st September 1980 (Annex B) for teachers in primary schools, secondary schools (other than technical intermediate schools) and special schools and for peripatetic and supply teachers.

The allowance for an unqualified teacher serving as a principal has been increased (regulations 4 and 14).

The allowance for teachers of handicapped pupils has been increased (regulations 6 and 16).

The rates of salary for unqualified teachers have been increased (regulations 7 and 17).

Regulations 8 and 18 provide new rates of payment for part-time teachers.

Regulations 9 to 12 and 19 to 22 update the arrangements affecting salary placings on the new salary scales.

These regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
