Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1980

Made 24th September 1980

Coming into operation 20th October 1980

The Department(a) of Agriculture, in exercise of the powers conferred on it by sections 3(3), 7(2) and 11(1) of the Marketing of Potatoes Act (Northern Ireland) 1964(b) and of every other power enabling it in that behalf, with the approval of the Department(a) of Finance hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1980 and shall come into operation on 20th October 1980.

Amendment of the Regulations of 1964

2.—(1) Regulation 8(3)(c) of the Marketing of Potatoes Regulations (Northern Ireland) 1964(d) shall be deleted.

(2) In paragraphs (1) and (4) of Regulation 8 (Fees for the inspection of potatoes) of the Marketing of Potatoes Regulations (Northern Ireland) 1964 for “99p”(e) there shall be substituted “£1.45”.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations increase the fee payable for the inspection of potatoes from 99p per tonne to £1.45 per tonne and revoke Regulation 8(3) of the Marketing of Potatoes Regulations (Northern Ireland) 1964.
