Employment in Agriculture (Amendment) Scheme (Northern Ireland) 1980

18th February 1980 Made 1st April 1980 Coming into operation

The Department of Agriculture, in exercise of the powers conferred by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department(b) of Finance hereby makes the following Scheme:

Citation and commencement

- 1.—(1) This Scheme may be cited as the Employment in Agriculture (Amendment) Scheme (Northern Ireland) 1980 and shall be included among the Schemes which may together be cited as the Employment in Agriculture Schemes (Northern Ireland) 1972-1980.
 - (2) This Scheme shall come into operation on 1st April 1980.

Amendment of duration of Scheme of 1972

2. In Article 6 of the Employment in Agriculture (Northern Ireland) Scheme 1972(c) "31st March 1981" shall be substituted for "31st March 1980".

EXPLANATORY NOTE

(This note is not part of the Scheme, but is intended to indicate its general purport.)

This Scheme extends the period during which the Employment in Agriculture (Northern Ireland) Scheme 1972 will operate until 31st March 1981.

The Employment in Agriculture (Northern Ireland) Scheme 1972 provides for payments to be made to or for the benefit of farmers producing any of the produce specified in the First Schedule thereto for any of the purposes specified in the Second Schedule thereto.
