The Department of Agriculture, in exercise of the powers conferred by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department(b) of Finance, hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Eggs (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1980 and shall come into operation on 1st April 1980.

Amendment to the Scheme of 1973

2. In Article 3 of the Eggs (Feed Price Allowance) Scheme (Northern Ireland) 1973(c) for "31st March 1980" there shall be substituted "31st March 1981".

Revocation

3. The Eggs (Feed Price Allowance) (Amendment No. 2) Scheme (Northern Ireland) 1979(d) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Scheme, but is intended to indicate its general purport.)

The Eggs (Feed Price Allowance) Scheme (Northern Ireland) 1973 provides for payments to hen egg producers in Northern Ireland to assist them in meeting the cost of poultry feed.

This Scheme extends the duration of the Scheme of 1973 from 31st March 1980 to 31st March 1981.
