Poultry (Feed Price Allowance) (Amendment) Scheme
(Northern Ireland) 1980

Made 4th March 1980

Coming into operation 1st April 1980

The Department of Agriculture, in exercise of the powers conferred by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) and now vested in it(b) and of every power enabling it in that behalf, with the approval of the Department(b) of Finance, hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Poultry (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1980 and shall come into operation on 1st April 1980.

Amendments to the Scheme of 1971

2. The Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971(c) is hereby amended as follows:

(1) In Article 3 for "31st March 1980" there shall be substituted "31st March 1981".

(2) In Article 2 for the words following "poultry packer" there shall be substituted "means the holder of a licence issued under the European Communities Poultry Meat (Hygiene) Regulations (Northern Ireland) 1977(d)".

Revocation

3. The Poultry (Feed Price Allowance) (Amendment No. 2) Scheme (Northern Ireland) 1979(e) is hereby revoked.

EXPLANATORY NOTE

*(This note is not part of the Scheme, but is intended to
indicate its general purport.)*

The Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971 provides for payments to poultry producers in Northern Ireland to assist them in meeting the cost of poultry feed.

This Scheme extends the duration of the Scheme of 1971 from 31st March 1980 to 31st March 1981.

This Scheme also amends the definition of "poultry packer" by requiring poultry packers for the purposes of the Scheme of 1971 to be persons licensed under European Communities legislation.
