Fisheries (Licence Duties) Byelaws (Northern Ireland) 1981

Made 26th October 1981

Coming into operation 1st January 1982

The Fisheries Conservancy Board for Northern Ireland in exercise of their powers under section 26 of the Fisheries Act (Northern Ireland) 1966(a) and of every other power enabling them in that behalf with the approval of the Department(b) of Agriculture hereby make the following Byelaws:

Citation and commencement

1. These Byelaws may be cited as the Fisheries (Licence Duties) Byelaws (Northern Ireland) 1981 and shall come into operation on 1st January 1982.

Substitution

2. There shall be substituted for Schedule I of the Fisheries Consolidated Amendment and Licence Duties Byelaws (Northern Ireland) 1969(c) the following Schedule:

EXPLANATORY NOTE

(This note is not part of the Byelaws.)

These Byelaws increase the licence duties for fishing with rod and line and hand line for salmon and freshwater fish and for commercial fishing engines used for the taking of salmon and freshwater fish other than eels. They also increase the fee payable for a licence which authorises the holder to buy and sell salmon, trout and eels.
