AGRICULTURE****Agriculture Health and Safety (Repeals and Modification)
Regulations (Northern Ireland) 1981**

Made 20th March 1981

Coming into operation 31st March 1981

The Department of Agriculture, in exercise of the powers conferred on it by Articles 17(3)(a) and (b), 46 and 54 of the Health and Safety at Work (Northern Ireland) Order 1978(a) and of every other power enabling it in that behalf, after consultation with the Health and Safety Agency for Northern Ireland and such other bodies as appear to the Department to be appropriate, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Agriculture Health and Safety (Repeals and Modification) Regulations (Northern Ireland) 1981 and shall come into operation on 31st March 1981.

Repeals

2. The provisions of the Agriculture (Safety, Health and Welfare Provisions) Act (Northern Ireland) 1959(b) ("the Act of 1959") mentioned in column 1 of Part I of Schedule 1 are hereby repealed to the extent specified in column 2 of that Schedule.

3. The provisions of the Agriculture (Miscellaneous Provisions) (Northern Ireland) Order 1975(c) mentioned in column 1 of Part II of Schedule 1 are hereby repealed to the extent specified in column 2 of that Schedule.

Modification

4. The provisions of the Act of 1959 mentioned in column 1 of Schedule 2 shall have effect subject to the modification specified in column 2 of that Schedule.

Modification taking effect on 31st March 1981.

Column 1 Provision	Column 2 Extent of Modification
Section 17	For the words "Sections one, two and three and regulations under any of those sections shall, insofar as they impose" substitute the words "Section two shall, insofar as it imposes".
Section 18	In the definition of "inspector" the words "Department of Agriculture" shall be substituted for the word "Ministry".

EXPLANATORY NOTE*(This note is not part of the Regulations.)*

These Regulations repeal or modify provisions of the Agriculture (Safety, Health and Welfare Provisions) Act (Northern Ireland) 1959 and repeal provisions of the Agriculture (Miscellaneous Provisions) (Northern Ireland) Order 1975.

These Regulations are a consequence of the revocation of the existing regulations made under the Agriculture (Safety, Health and Welfare Provisions) Act (Northern Ireland) 1959, carried out under the Agriculture (Safety, Health and Welfare Provisions) Act (Northern Ireland) 1959 (Repeals and Modification) Regulations (Northern Ireland) 1979.
