ROAD TRAFFIC AND VEHICLES

One-Way Traffic (Carrickfergus) Order
(Northern Ireland) 1982

Made 17th May 1982

Coming into operation 28th June 1982

WHEREAS the Department of the Environment (in this order referred to as "the Department") has published a notice in compliance with Article 23(1) and (2) of the Road Traffic (Northern Ireland) Order 1981(a);

AND WHEREAS no objection has been received;

NOW THEREFORE the Department in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf hereby makes the following order:—

Citation and commencement

1. This order may be cited as the One-Way Traffic (Carrickfergus) Order (Northern Ireland) 1982 and shall come into operation on 28th June 1982.

Revocation

2. The Bye-laws specified in Schedule 1 are hereby revoked.

Prohibition

3. No person shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit any vehicle to proceed on the roads or lengths of road specified in column 1 of Schedule 2 in a direction other than that specified in relation to those roads or lengths of road in column 2.

1. Bye-laws in respect of one-way traffic made by Carrickfergus Borough Council on 5th April 1971 and confirmed by the Ministry of Home Affairs on 28th April 1971.
2. Bye-laws in respect of one-way traffic in Queen Street and Nelson Street, Carrickfergus, made by the Department of the Environment for Northern Ireland on 27th February 1974.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order revokes and re-enacts with amendments the Bye-laws in respect of one-way traffic specified in Schedule 1.

The principal amendments are the:—

- (a) re-introduction of two-way traffic in Antrim Street, Cheston Street, Essex Street, Irish Quarter South, Lancasterian Street (Lower), Marine Highway Link Road and North Street (Upper), all in the town of Carrickfergus.
- (b) provision of a one-way system of traffic in part of Barn Road, Carrickfergus.

Any person who acts in contravention of the order shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding £100.

Traffic signs indicating the effect of the order have been erected on the roads.
