## FISHERIES

Foyle Area (Licensing of Fishing Engines) (Amendment)  
Regulations 1982

Made . . . . . 15th January 1982

Coming into operation . . . . . 27th February 1982

The Foyle Fisheries Commission, in exercise of its powers under section 13 of the Foyle Fisheries Act 1952(a) and section 13 of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for Fisheries and Forestry in the Republic of Ireland and of the Department(c) of Agriculture for Northern Ireland, hereby makes the following regulations:—

1. These Regulations may be cited as the Foyle Area (Licensing of Fishing Engines) (Amendment) Regulations 1982, and shall come into operation on 27th February 1982.

2. The Schedule to the Foyle Area (Licensing of Fishing Engines) Regulations 1976(d) shall be deleted and the following Schedule substituted:—

Drift Net used wholly to seaward of Lough Foyle (the seaward limit of which for the purpose of these regulations shall be deemed to be an imaginary straight line drawn between Greencastle Fort in the County of Donegal and the Martello Tower at Magilligan Point in the County of Londonderry) . . .	70.00
Drift Net used wholly in Lough Foyle, or partly in the said Lough Foyle and partly seaward of the seaward limit of Lough Foyle as aforesaid . . .	84.00
