### To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

In exercise of the powers conferred upon me by section 1 of the Registration of Births, Deaths and Marriages (Fees, etc.) Act (Northern Ireland) 1955(a) as modified by section 40 of and paragraph 4 of Schedule 5 to the Northern Ireland Constitution Act 1973(b) and section 9 of the Marriage Act 1983(c) I hereby make the following Order:

#### Citation, commencement and interpretation

1.—(1) This Order may be cited as the Marriages (Fees) Order (Northern Ireland) 1984 and shall come into operation on 1st May 1984.

(2) In this Order "the Act" means the Marriage Act 1983.

### Fee payable

2. The fee payable for a service provided under a section of the Act specified in column 1 of the Schedule being a service described in column 2 of the Schedule, shall be the fee specified in relation to that service in column 3 of the Schedule.

#### Exemption

**3.** No fee shall be payable under this Order by any person who is in receipt of benefit under the Supplementary Benefits (Northern Ireland) Order 1977(d).

# By and to whom fees are payable

4.—(1) Any fee payable under this Order shall be payable by the person who gives notice of intention to marry under section 3(2) of the Act.

(2) Any fee payable under this Order shall be payable to the Registrar General.
