The Department of Health and Social Services in exercise of the powers conferred on it by Articles 98, 106 and 107 of and Schedule 15 to the Health and Personal Social Services (Northern Ireland) Order 1972(a) and of all other powers enabling it in that behalf, with the approval of the Department of Finance and Personnel(b), hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the General Ophthalmic Services (Amendment) Regulations (Northern Ireland) 1984 and shall come into operation on 1st April 1984.

Amendment of regulations

- 2. The Health and Personal Social Services (General Ophthalmic Services) Regulations (Northern Ireland) 1975(c) shall be further amended as follows:
 - (1) in regulation 18(2) for "95p" there shall be substituted "£1.00";
 - (2) in regulation 18(3) for "£15.50" there shall be substituted "£16.50";
 - (3) for Schedule 3 there shall be substituted the following Schedule:

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations further amend the Health and Personal Social Services (General Ophthalmic Services) Regulations (Northern Ireland) 1975 by increasing the charges for lenses supplied under the general ophthalmic services.

The revised charges for a single-vision glass lens range from an increase from £4.00 to £4.25, to an increase from £8.95 to £9.45..

The charges for a solid glass bifocal lens are increased from £11.65 to £12.25 at the minimum to £15.50 to £16.50 at the maximum.

Charges for other lenses are increased from £4.65 to £4.85 for a single-vision lens; £9.60 to £10.15 for a fused glass spherical bifocal lens; £10.30 to £10.70 for a fused glass astigmatic bifocal lens; and £9.20 to £9.40 for a lens of any other description.

Additional charges in respect of prescribed prisms are increased from £2.80 to £3.25 for a single-vision lens (lens up to 6.00 spherical or 4.00 cylindrical) and from £1.20 to £1.50 for a bifocal lens.

The maximum charge in respect of any lens is increased from £15.50 to £16.50.
