Foyle Area (Control of Netting) (Amendment) Regulations 1985

Made 17th April 1985
 Coming into operation 27th May 1985

The Foyle Fisheries Commission, in exercise of its powers under section 13(1) of the Foyle Fisheries Act 1952(a) and section 13(1) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for Fisheries and Forestry in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following regulations:—

Citation and commencement

1. These Regulations may be cited as the Foyle Area (Control of Netting) (Amendment) Regulations 1985 and shall come into operation on 27th May 1985.

Amendment to the Foyle Area (Control of Netting) (Amendment) Regulations 1983

2. The Foyle Area (Control of Netting) (Amendment) Regulations 1983(e) shall be amended as follows:—

In Regulation 1(c) for “1st June 1985” there shall be substituted “1st June 1986.”

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Foyle Area (Control of Netting) (Amendment) Regulations 1983 to delay for one year the coming into operation of further restrictions on the materials which may be used in the construction of commercial fishing nets for the capture of salmon or trout. The effect of this delay will be that a ban on 2 types of net in common use, namely, a multistrand monofilament and single throw monopy which is also known as super nylon or Japanese netting, will take effect from 1st June 1986 instead of 1st June 1985.

The Foyle Area (Control of Netting) (Amendment) Regulations 1983 amend the Foyle Area (Control of Netting) Regulations (Northern Ireland) 1981 which control and restrict netting for salmon and trout in the Foyle Area.
