ULSTER SAVINGS CERTIFICATES

Ulster Savings Certificates (Index Linked) (Supplement) Regulations 1985

The Department of Finance and Personnel(a) in exercise of the powers conferred upon it by Section 15(1) of the Exchequer and Financial Provisions Act (Northern Ireland) 1950(b) and of every other power enabling it in that behalf hereby makes the following regulations:

- 1. These regulations may be cited as the Ulster Savings Certificates (Index Linked) (Supplement) Regulations 1985 and shall come into operation on 1st November 1985.
- 2. In these regulations "index linked certificate" has the same meaning as in regulation 5 of the Ulster Savings Certificates Regulations 1962(c).
- 3.—(1) On and after 1st November 1985 the amount repayable on an index linked certificate held on 31st October 1984 and which is still held on 31st October 1985 shall be supplemented by adding to the amount repayable an amount calculated in accordance with paragraph (2).
- (2) The amount to be added in accordance with this regulation shall be calculated by multiplying an amount equal to 3.0 per cent of the amount repayable on a certificate at 31st October 1984 by the Retail Price Index figure applicable to the month of repayment and dividing the product by the Retail Price Index figure applicable to November 1985.
- **4.**—(1) The amount repayable on an index linked certificate purchased during or after the month of November 1984 but before the month of October 1985 and held for at least one year shall be supplemented by adding an amount calculated in accordance with paragraph (2).
- (2) The amount to be added in accordance with this regulation shall be calculated by multiplying an amount equal to 0.25 per cent of the purchase price of the certificate for each whole month from the month of purchase of the certificate until the end of October 1985 by the Retail Price Index figure applicable to the month of repayment or the first anniversary date of purchase (whichever is the later) and dividing the product by the Retail Price Index figure applicable to November 1985.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations provide for a supplement of 3.0% to be added on or after 1st November 1985 to the amount repayable on an index linked Ulster Savings Certificate held at 31st October 1984 and still held at 31st October 1985. The supplement will be calculated on the amount repayable on the certificate at 31st October 1984 which is the purchase price, index increase, bonuses and the previous supplements.

The regulations also provide that for an index linked certificate purchased in or after November 1984 but before October 1985 a supplement of 0.25% of the purchase price for each whole calendar month from the month of purchase up to the end of October 1985 will be added to the amount repayable on or after the first anniversary of purchase of the certificate. Provision is also made for the indexing of the supplement.

The supplement is additional to any index increase, bonuses or other supplements payable on the certificate.
