ROAD TRAFFIC AND VEHICLES

Public Service Vehicles (Fees) (Amendment) Regulations
(Northern Ireland) 1985

Made 26th July 1985

Coming into operation 2nd September 1985

The Department of the Environment in exercise of the powers conferred on it by Articles 61(1), 66(1) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf and with the approval of the Department of Finance and Personnel(b) as regards regulation 2 makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Public Service Vehicles (Fees) (Amendment) Regulations (Northern Ireland) 1985 and shall come into operation on 2nd September 1985.

Amendment of the 1985 Regulations

2. In Schedule 7 to the Public Service Vehicles Regulations (Northern Ireland) 1985(c)—

(a) in paragraph 1(a) for “£10·00” there shall be substituted “£10·70”;

(b) for paragraph 2 there shall be substituted—

“2. *Fee payable with re-application for a vehicle licence (see regulation 9(2))*

(a) Taxi £10·70

(b) Bus constructed or adapted to carry more than
12 passengers £31·50

(c) Bus not so constructed or adapted £22·00”; and

(c) for paragraph 3 there shall be substituted—

“3. *Fee payable with re-application for a vehicle licence when application is made within 21 days of the notice of refusal (see regulation 9(3))*

(a) Taxi £ 5·35

(b) Bus constructed or adapted to carry more than
12 passengers £16·00

(c) Bus not so constructed or adapted £11·00”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Public Service Vehicles Regulations (Northern Ireland) 1985 by—

- (1) increasing the fee payable on application for a licence for a taxi from £10·00 to £10·70 (regulation 2(a));
- (2) increasing the fee payable (following refusal of a licence) on re-application for a licence for a taxi from £10·00 to £10·70 (regulation 2(b));
- (3) increasing from £5·00 to £5·35 the fee payable where a re-application is made within 21 days from a notice of refusal and the taxi is presented for re-inspection on a date appointed by the Department (regulation 2(c));
- (4) correcting a few minor drafting errors (regulation 2(b) and (c)).
