**Colleges of Education Salaries (Amendment) Regulations  
(Northern Ireland) 1985**

Made . . . . . 8th November 1985

Coming into operation . . . . . 29th November 1985

The Department of Education, in exercise of the powers conferred on it by Articles 57(1) and (4) and 125(1) of the Education and Libraries (Northern Ireland) Order 1972(a) and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b) and of every other power enabling it in that behalf, hereby makes the following Regulations:

*Citation and commencement*

1. These Regulations may be cited as the Colleges of Education Salaries (Amendment) Regulations (Northern Ireland) 1985 and shall come into operation on 29th November 1985 and shall have effect on and from 1st April 1985.

*Amendment of Colleges of Education Salaries Regulations (Northern Ireland) 1981*

2. The Colleges of Education Salaries Regulations (Northern Ireland) 1981(c) shall be amended as follows:—

(1) in regulation 10(1) and (2) (allowances for head of department) for “£1,338” and “£1,176” there shall be substituted respectively “£1,404” and “£1,236”;

(2) in regulation 11 (allowances for principal lecturer) for “1984” where it occurs and “4.6%” there shall be substituted respectively “1985” and “5%”;

(3) in paragraphs 1, 7 and 8 of Schedule I for the existing tables of salary scales there shall be substituted the respective tables of salary scales set out in the Schedule;

(4) in Schedule II (Entry to Scales of Salaries) for “1984” in all places where it occurs there shall be substituted “1985”.

## EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These regulations amend the Colleges of Education Salaries Regulations (Northern Ireland) 1981 and give effect from 1st April 1985 to a pay increase of 5% for academic staff in colleges of education.

The regulations also provide for increased rates of allowance in certain cases with effect from 1st April 1985.

These regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
