Ballintoy Harbour Order (Northern Ireland) 1985

Made 26th February 1985

Coming into operation 10th April 1985

*To be laid before Parliament under paragraph 3(3) of Schedule 1
to the Northern Ireland Act 1974*

The Department of Economic Development in exercise of the powers conferred by section 1(1) of and Schedule 1 to the Harbours Act (Northern Ireland) 1970(a) and now vested in it(b) and of every other power enabling it in that behalf, and having consulted with Moyle District Council, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Ballintoy Harbour Order (Northern Ireland) 1985 and shall come into operation on 10th April 1985.

Interpretation

2. In this Order “the harbour” means the harbour at Ballintoy.

Establishment of Council as harbour authority

3.—(1) Moyle District Council is hereby established as the harbour authority for the harbour.

(2) The objects of the harbour authority shall be the improvement, maintenance and management of the harbour.

Harbour limits

4.—(1) The harbour limits (that is to say, the limits within which the harbour authority has authority by virtue of the Harbours Act (Northern Ireland) 1970 and within which may be exercised the powers of any harbour master it may appoint) shall comprise the harbour and the lands adjacent to the harbour, together with seaward approaches to the harbour, which limits are shown by a continuous orange line on the map.

(2) In the event of any discrepancy between the description of the harbour limits contained in paragraph (1) and the harbour limits as shown on the map, the map shall be deemed to be correct and shall prevail.

(3) In this Article “the map” means the map marked “Ballintoy Harbour — Harbour Limits” which has been signed and sealed with reference to this Order and deposited at the office of the Department of Economic Development, Netherleigh, Massey Avenue, Belfast BT4 2JP, where it is available for inspection at any reasonable hour.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order establishes Moyle District Council as the harbour authority for the harbour at Ballintoy, County Antrim, with the objects of improving, managing and maintaining the harbour. The Order also defines the harbour limits.
