**Animals and Poultry (Quarantine Charges) (Amendment) Order
(Northern Ireland) 1986**

Made 1st May 1986

Coming into operation 9th June 1986

The Department of Agriculture, in exercise of the powers conferred on it by Article 50(1) of the Diseases of Animals (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Animals and Poultry (Quarantine Charges) (Amendment) Order (Northern Ireland) 1986 and shall come into operation on 9th June 1986.

Amendment of the 1983 Order

2. The Schedule to the Animals and Poultry (Quarantine) (Charges) Order (Northern Ireland) 1983(b) is replaced by the Schedule to this Order.

SCHEDULE

Article 2

Charges

1.—(a) The charge per head for the undermentioned animals for their feeding, housing and care in a quarantine station for a period of 3 weeks shall be:—

cattle	£181.00
pigs or deer	£ 90.00
sheep or goats	£ 36.00

(b) The charge per head for such animals for such feeding, housing and care for a period of more than 3 weeks or less than 3 weeks shall be:—

cattle	£8.62 per day
pigs or deer	£4.29 per day
sheep or goats	£1.71 per day

2.—(a) The charge per head for poultry for their housing and care for a period of 10 weeks shall be £1.00.

(b) The charge per head for poultry for such housing and care for a period of more than 10 weeks or less than 10 weeks shall be 1.43p per day.

3. There shall be no charge for hatching eggs during their incubation at a quarantine station but after such hatching eggs have hatched the charge for the poultry resulting from such hatching shall be as set out in paragraph 2.

EXPLANATORY NOTE

(This note is not part of the Order.)

The Order increases the charges made by the Department of Agriculture for the feeding, housing and care of imported cattle, pigs, deer, sheep and goats during a 3 week period of quarantine and pro-rata, on a daily basis, for a longer or shorter period.

The period of quarantine in respect of animals has been reduced by 1 week to 3 weeks. The period of quarantine in respect of poultry remains unaltered at 10 weeks.

The charge is increased by £100.00 for cattle, £49.50 for pigs and deer and £19.88 for sheep and goats. In the case of poultry the charge which relates only to housing and care during a 10 week period of quarantine is increased by £0.03 and pro-rata, on a daily basis, for a longer or shorter period.
