BETTING, GAMING AND LOTTERIES**Gaming Machine (Forms of Certificates and Permit)
Regulations (Northern Ireland) 1986**

Made 6th May 1986

Coming into operation 1st June 1986

The Department of Health and Social Services, in exercise of the powers conferred on it by Articles 86(1), 86(2) and 97(1) of the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985(a) and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Gaming Machine (Forms of Certificates and Permit) Regulations 1986 and shall come into operation on 1st June 1986.

Forms of certificates and permit

2.—(1) A gaming machine certificate shall be in Form 1 in the Schedule.

(2) A gaming machine permit shall be in Form 2 in the Schedule.

(3) A certificate of registration shall be in Form 3 in the Schedule.

(4) There shall be entered on each certificate or permit such of the entries as are therein set out as relate to the orders made by the court whether upon the grant or renewal of each certificate or upon the grant of the permit.

(5) Every entry on each certificate or permit shall be verified by the signature of the clerk of petty sessions for the court of summary jurisdiction which made the order and shall state the petty sessions district for which the court acted when making the order.

Duplicate certificates or permits under Article 179 to be issued

3. A clerk of petty sessions shall for the purposes of Article 179(2) of the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985 issue a duplicate of the certificate or permit headed "DUPLICATE" and that duplicate shall be issued and certified in accordance with the provisions of that Article.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations prescribe the form of gaming machine certificates, gaming machine permits and certificates of registration of clubs issued by the court or the clerk of petty sessions.

Articles 86(1), 86(2) and 97(1) of the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985 are the enabling provisions under which these regulations are made. They are brought into operation on 1st June 1986 by the Betting, Gaming, Lotteries and Amusements (1985 Order) (Commencement No. 1) Order (Northern Ireland) 1986. (S.R. 1986 No. 124 (C. 3)).
