The Housing Benefits (Amendment No. 2) Regulations (Northern Ireland) 1986

Made 3rd June 1986

Coming into operation 1st July 1986

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 3(2) of the Housing Benefits (Northern Ireland) Order 1983(a) and acting jointly with the Department of the Environment, in exercise of the powers conferred on them by Article 3(1) of that Order, in each case with the consent of the Department of Finance and Personnel, and in exercise of all other powers enabling them in that behalf, hereby make the following regulations:

Citation and commencement

1. These regulations may be cited as the Housing Benefits (Amendment No. 2) Regulations (Northern Ireland) 1986 and shall come into operation on 1st July 1986.

Amendment of the Housing Benefits Regulations (Northern Ireland) 1985

2. In Schedule 2 to the Housing Benefits Regulations (Northern Ireland) 1985(b) (amounts to be disregarded when ascertaining weekly income for any housing benefit), the following paragraph shall be inserted after paragraph 18—

“18A. Any Job Start Allowance payable pursuant to arrangements made by the Department of Economic Development(c) under section 1(1) of the Employment and Training Act (Northern Ireland) 1950(d).”

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Housing Benefits Regulations (Northern Ireland) 1985. They correspond to provision contained in regulations made by the Secretary of State for Social Services in relation to Great Britain and accordingly, by virtue of section 10(2) of, and paragraph 21 of Schedule 3 to, the Social Security Act 1980 (c. 30) are not subject to the requirement of section 10(1) of that Act for prior reference to the Social Security Advisory Committee.

They provide that, in ascertaining a person's weekly income for the purpose of calculating entitlement to housing benefit, any Job Start Allowance payable under arrangements made by the Department of Economic Development is disregarded.
