ROAD TRAFFIC AND VEHICLES

Large Private Passenger Vehicles (Certification) (Fees)
(Amendment) Regulations (Northern Ireland) 1986

Made 18th July 1986

Coming into operation 1st September 1986

The Department of the Environment in exercise of the powers conferred on it by Articles 67(3), 69 and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf and with the approval of the Department of Finance and Personnel(b) as regards regulation 3 makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Large Private Passenger Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1986 and shall come into operation on 1st September 1986.

Revocation

2. The Large Private Passenger Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1985(c) are revoked.

Amendment of the 1982 Regulations

3. For regulation 6 of the Large Private Passenger Vehicles (Certification) Regulations (Northern Ireland) 1982(d) there shall be substituted—

“Fees

6. The fee payable shall be—

(a) for inspection of a vehicle in accordance with regulation 3(3) or 5(3) £11.90;

(b) for re-inspection of a vehicle in accordance with regulation 5(4) £5.95.”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Large Private Passenger Vehicles (Certification) Regulations (Northern Ireland) 1982 by—

- (a) increasing the fee payable on application for inspection of a large private passenger vehicle from £10·70 to £11·90;
- (b) increasing the fee payable (following a refusal of a certificate) on re-application for inspection of a large private passenger vehicle from £10·70 to £11·90;
- (c) increasing from £5·35 to £5·95 the fee payable where a re-application is made within 21 days from the date of service of a notice of refusal and the vehicle is presented for re-inspection on a date appointed by the Department.
