ROAD TRAFFIC AND VEHICLES

Control of Traffic (Portadown) Order (Northern Ireland) 1986

Made 28th July 1986

Coming into operation 14th September 1986

WHEREAS the Department of the Environment has published notice in compliance with Article 23(1) and (2) of the Road Traffic (Northern Ireland) Order 1981(a);

AND WHEREAS no objection has been received;

NOW THEREFORE the Department in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf makes the following Order:—

Citation and commencement

1. This Order may be cited as the Control of Traffic (Portadown) Order (Northern Ireland) 1986 and shall come into operation on 14th September 1986.

Revocation

2. The Prohibition of Right-Hand Turn (Portadown) Order (Northern Ireland) 1979(b) is revoked.

Prohibition of right-hand turn

3. Subject to Article 4 a person shall not cause or permit a vehicle proceeding on the roads specified in column 1 of the Schedule to make a right-hand turn into the roads specified in column 2 while proceeding in the direction specified in column 3.

Exemptions

4. Article 3 shall not apply to:

- (a) vehicles being used in an emergency for fire brigade, ambulance or police purposes; or
- (b) a vehicle the driver of which is acting upon the direction or with the permission of a constable in uniform or of a traffic warden.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order revokes and re-enacts the provisions of the Prohibition of Right-Hand Turn (Portadown) Order (Northern Ireland) 1979 and also prohibits vehicles proceeding in a north-easterly direction along Bridge Street, Portadown, from making a right-hand turn into Goban Street.

Traffic signs indicating the effect of the Order have been or will be erected on the roads.

Any person who acts in contravention of the Order shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding £400.
