**The Mental Health (Payment of Fees) (Amendment) Regulations
(Northern Ireland) 1986***Made* 15th April 1986*Coming into operation* 26th May 1986

The Department of Health and Social Services in exercise of the powers conferred on it by sections 90 and 112 of the Mental Health Act (Northern Ireland) 1961(a) and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b) and of every other power enabling it in that behalf, and with the consent of the Department of Finance and Personnel(c), hereby makes the following Regulations:—

Citation and commencement

1. These regulations may be cited as the Mental Health (Payment of Fees) (Amendment) Regulations (Northern Ireland) 1986 and shall come into operation on 26th May 1986.

Amendment

2. For regulation 3 of the Mental Health (Payment of Fees) Regulations (Northern Ireland) 1973(d) there shall be substituted the following regulation:—

“3. As from 1st June 1985 a medical practitioner who furnishes a recommendation—

- (a) for admission under section 12 or 15 of the Act in respect of the admission of a patient to a hospital, or
- (b) for guardianship under section 21 of the Act in respect of the reception of a patient into guardianship,

shall receive a fee of—

- (i) £26.35 (formerly £24.80) for consultant or specialist work,
- (ii) £21.15 (formerly £19.90) for medical work other than consultant or specialist work,

for each recommendation.”.

Revocation

3. The Mental Health (Payment of Fees) (Amendment) Regulations (Northern Ireland) 1985(e) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations increase with effect from 1st June 1985 the fees for consultant or specialist work and for medical work other than consultant or specialist work payable by Health and Social Services Boards to medical practitioners for recommendations made under sections 12, 15 and 21 of the Mental Health Act (Northern Ireland) 1961.

The Regulations (Regulation 3) also revoke the Mental Health (Payment of Fees) (Amendment) Regulations (Northern Ireland) 1985 which have been superseded.

The Regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
