

1987 No. 121 (C. 4)**· SOCIAL SECURITY****The Social Security (1986 Order) (Commencement No. 4) Order (Northern Ireland) 1987**

Made 19th March 1987

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(3) of the Social Security (Northern Ireland) Order 1986(a), paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

Citation and interpretation

1.—(1) This order may be cited as the Social Security (1986 Order) (Commencement No. 4) Order (Northern Ireland) 1987.

(2) In this order “Order” means the Social Security (Northern Ireland) Order 1986.

Appointed day

2. Subject to Article 3, the day appointed for the coming into operation of the provisions of the Order specified in Schedule 1 is 6th April 1987.

Exceptions

3. The appointment of 6th April 1987 for the coming into operation of paragraph 43 of Schedule 9 to the Order and the repeal, in Schedule 10 to the Order, of the words following “pension rate” in section 2(6)(b) of the Industrial Injuries and Diseases (Northern Ireland Old Cases) Act 1975(c) (amendment to rates of allowance under Northern Ireland Old Cases Act regulations) shall not have effect in relation to any person who has retired, or is treated as having retired, from regular employment, for the purposes of the Social Security (Northern Ireland) Act 1975(d), for so long as he continues to be treated as retired for those purposes.

EXPLANATORY NOTE

(This note is not part of the Order.)

Article 2 of this order appoints 6th April 1987 for the coming into operation of the provisions of the Social Security (Northern Ireland) Order 1986 which are specified in Schedule 1 to this order, including provisions which alter entitlement to benefit for industrial injuries.

Article 3 excepts certain pensioners from the bringing into operation, by this order, of some of the alterations.

Article 4 amends the Social Security (1986 Order) (Commencement No. 3) Order (Northern Ireland) 1987 by omitting from the provisions brought into operation on 6th April 1987 paragraph 5(1)(b) of Schedule 8 to the Social Security (Northern Ireland) Order 1986 (removal of existing power to recalculate earnings factors) and the repeals of provisions specified in Schedule 2 to this order, which provide for awards of industrial death benefit.

The bringing into operation of these repeals will require a further commencement order.
