**Payment of Teachers' Salaries and Allowances
Regulations (Northern Ireland) 1987**

Made 24th March 1987

Coming into operation 15th April 1987

The Department of Education, in exercise of the powers conferred on it by Articles 69(3) and 134(1) of the Education and Libraries (Northern Ireland) Order 1986(a) and of every other power enabling it in that behalf, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Payment of Teachers' Salaries and Allowances Regulations (Northern Ireland) 1987 and shall come into operation on 15th April 1987.

Revocation

2. The Payment of Teachers' Salaries Regulations (Northern Ireland) 1974(b) are hereby revoked.

Interpretation

3. In these Regulations "Salaries Regulations" means the Teachers' Salaries Regulations (Northern Ireland) 1984(c) or the Further Education Teachers' Salaries Regulations (Northern Ireland) 1985(d).

Payment of teachers' salaries and allowances

4.—(1) Except where the managers and the Department agree as provided in paragraph (2), the salaries and allowances of full-time teachers, temporary teachers and part-time teachers in voluntary grammar schools shall be paid in accordance with the appropriate Salaries Regulations by the managers and Article 69(3) of the Education and Libraries Order (Northern Ireland) 1986 shall apply accordingly.

(2) The Department and the managers may agree that paragraph (1) as it applies in relation to full-time teachers shall not apply to that school.

5. Part-time teachers employed in institutions of further education shall be paid in accordance with the appropriate Salaries Regulations by the board by which they are employed.

6. Full-time teachers employed in institutions of further education who undertake additional teaching duties shall be paid for such duties in accordance with the appropriate Salaries Regulations by the board by which they are employed.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations consolidate the Payment of Teachers' Salaries Regulations (Northern Ireland) 1974, the Payment of Teachers' Salaries (Amendment) Regulations (Northern Ireland) 1980 and the Teachers' Salaries and Allowances (Payment) (Amendment) Regulations (Northern Ireland) 1986.

The regulations allow the Department of Education to assume responsibility for the payment of salaries to full-time teachers in voluntary grammar schools where the school managers consent and provide that full-time teachers employed in institutions of further education who undertake additional teaching duties shall be paid by the Education and Library Board by which they are employed.

The regulations also provide that part-time teachers in institutions of further education shall be paid by the Education and Library Board by which they are employed.
