The Social Security (1986 Order) (Commencement No. 2) Order (Northern Ireland) 1987

Made 19th January 1987

The Department of Health and Social Services, with the consent of the Lord Chancellor, in exercise of the powers conferred on it by Article 1(4) of the Social Security (Northern Ireland) Order 1986(a), and paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

Citation and interpretation

- 1.—(1) This order may be cited as the Social Security (1986 Order) (Commencement No. 2) Order (Northern Ireland) 1987.
- (2) In this order "the Order" means the Social Security (Northern Ireland) Order 1986.

Appointed day for Article 53 of, and Schedule 5 to, the Order

- 2.—(1) Subject to paragraph (2), the day appointed for the coming into operation of Article 53 of, and Schedule 5 to, the Order (adjudication) is 6th April 1987.
- (2) The following provisions of paragraph 6 of Schedule 5 to the Order (appeal from social security appeal tribunal to Commissioner) shall not have effect in relation to any decisions of social security appeal tribunals which are recorded in writing before the appointed day—
 - (a) sub-paragraph (1);
 - (b) sub-paragraph (3) so far as it substitutes a new subsection (5A) for subsection (5) of section 101 of the principal Act(c).
