**Foyle Area (Control of Netting) (Amendment) Regulations 1987**

Made . . . . . 30th April 1987

Coming into operation . . . . . 29th May 1987

The Foyle Fisheries Commission, in exercise of its powers under section 13(1) of the Foyle Fisheries Act 1952(a) and section 13(1) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for the Marine in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following Regulations:—

*Citation and commencement*

1. These Regulations may be cited as the Foyle Area (Control of Netting) (Amendment) Regulations 1987 and shall come into operation on 29th May 1987.

*Amendment to the Foyle Area (Control of Netting) (Amendment) Regulations 1983*

2. The Foyle Area (Control of Netting) (Amendment) Regulations 1983(e) shall be amended as follows:—

For the definition of “multifilament yarn” in Regulation 2 there shall be substituted—

“multifilament yarn” means a yarn constructed from a group of continuous filaments each filament of which has a diameter not greater than 0.1 mm;”.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations amend the Foyle Area (Control of Netting) (Amendment) Regulations 1983 with regard to the materials which may be used in the construction of commercial fishing nets for the capture of salmon or trout in the Foyle Area. A new definition of multifilament yarn is substituted which increases the maximum diameter of each filament of thread in multifilament yarn from 0.05 mm to 0.1 mm.

The ban on the use of multistrand monofilament and single throw monopoly which is also known as super nylon or Japanese netting which will come into effect on 1st June 1987 is not affected by this amendment.

The Foyle Area (Control of Netting) (Amendment) Regulations 1983 amend the Foyle Area (Control of Netting) Regulations 1981 which control and restrict netting for salmon and trout in the Foyle Area.
