The Department of the Environment in exercise of the powers conferred on it by Article 65(1) of the Road Traffic (Northern Ireland) Order 1981(a) makes and confirms the following Bye-Laws:

Citation and commencement

1. These Bye-Laws may be cited as the Motor Hackney Carriage (Londonderry) (Amendment) Bye-Laws (Northern Ireland) 1987 and shall come into operation on 1st September 1987.

Revocation

2. The Motor Hackney Carriage (Londonderry) (Amendment) Bye-Laws (Northern Ireland) 1985(**b**) are revoked.

Bye-Laws amended

3. For the schedule to the Bye-Laws made in respect of Motor Hackney Carriages standing or plying for hire by the Londonderry Council on 28th May 1963 and confirmed by the Ministry of Home Affairs on 26th June 1963(c) there shall be substituted:—

EXPLANATORY NOTE

(This note is not part of the Bye-Laws.)

These Bye-Laws further amend the Bye-Laws relating to Motor Hackney Carriages standing or plying for hire made by Londonderry Council on 28th May 1963 by:—

(1) abolishing 3 taxi stands in Rossville Street and replacing them with 6 taxi stands at an alternative site in Rossville Street; and

(2) abolishing 3 taxi stands at Great James Street.
