## Lands Tribunal (Salaries) Order (Northern Ireland) 1987

*Made* . . . . . 9th September 1987

*Coming into operation* . . . . . 21st October 1987

*To be laid before Parliament under paragraph 3(3) of  
Schedule 1 to the Northern Ireland Act 1974*

In exercise of the powers conferred by section 2(5) of the Lands Tribunal and Compensation Act (Northern Ireland) 1964(a) and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and now vested in me(c) and of all other powers enabling it in that behalf, I hereby make the following Order:

*Title and commencement*

1. This Order may be cited as the Lands Tribunal (Salaries) Order (Northern Ireland) 1987 and shall come into operation on 21st October 1987.

*Revocation*

2. The Lands Tribunal (Salaries) (No. 2) Order (Northern Ireland) 1986(d) is hereby revoked.

*Increases in salaries*

3.—(1) The annual salary payable to the President of the Lands Tribunal shall be increased as follows—

- (a) from £23,000 to £23,978 from 1st April 1987;
- (b) from £23,978 to £47,955 from 1st May 1987;
- (c) from £47,955 to £48,250 from 1st October 1987.

(2) The annual salary payable to any other member of the Lands Tribunal shall be increased as follows—

- (a) from £41,500 to £43,264 from 1st April 1987;
- (b) from £43,264 to £43,500 from 1st October 1987.

## EXPLANATORY NOTE

*(This note is not part of the Order.)*

This Order provides for increases in the annual salaries payable to members of the Lands Tribunal for Northern Ireland.

Article 3(1) provides for payment to the President of an annual salary of £23,978 from 1st April 1987, £47,955 from 1st May 1987 and £48,250 from 1st October 1987. The post of President was occupied on a part-time basis until 30th April 1987 but from 1st May 1987 it became a full-time post. Under Article 3(2) the annual salary payable to any other member of the Lands Tribunal is £43,264 from 1st April 1987 and £43,500 from 1st October 1987.

The Order is made with retrospective effect from 1st April 1987 under section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.

Article 2 revokes the Lands Tribunal (Salaries) (No. 2) Order (Northern Ireland) 1986.
