SOCIAL SECURITY

The Social Security (Widow's Benefit and Retirement Pensions) (Amendment) Regulations (Northern Ireland) 1987

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 29(5)(b) and 39(4) of, and Schedule 17 to, the Social Security (Northern Ireland) Act 1975(a), paragraph 3 of Schedule 1 to the Social Security Pensions (Northern Ireland) Order 1975(b), and Article 84(1) of the Social Security (Northern Ireland) Order 1986(c) and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Social Security (Widow's Benefit and Retirement Pensions) (Amendment) Regulations (Northern Ireland) 1987 and shall come into operation on 11th April 1988.
- (2) In these regulations "the principal regulations" means the Social Security (Widow's Benefit and Retirement Pensions) Regulations (Northern Ireland) 1979(d).
- (3) The Interpretation Act 1978(e) shall apply to these regulations as it applies to an Act of the United Kingdom Parliament.

Amendment of the principal regulations

- 2.—(1) The principal regulations shall be amended in accordance with paragraphs (2) to (6) of this regulation.
- (2) In regulation 5(1) for "section 120 of the Act" there shall be substituted "Article 64 of the Social Security (Northern Ireland) Order 1986".
 - (3) In regulation 7(b) "a widow's allowance or" shall be omitted.
 - (4) In regulation 11—
 - (a) in paragraph (1)(c) for "40" there shall be substituted "45";
 - (b) in paragraph (3)(a) for "50" there shall be substituted "55".

- (5) In regulation 13—
- (a) in paragraph (1)(a) for "40" there shall be substituted "45";
- (b) in paragraph (3) for "50" there shall be substituted "55".
- (6) In regulation 16(1) for sub-paragraph (a) there shall be substituted the following sub-paragraph—
 - "(a) any person under the age of 19 residing with the widow shall be deemed to be a child falling within section 25(2) of the Act if—
 - (i) the requirement of section 25(2)(a) is satisfied in his case and child benefit would have been payable in respect of him had he not been absent from Northern Ireland and had a claim for it been made in the manner prescribed under Article 8 of the Child Benefit (Northern Ireland) Order 1975(a), or
 - (ii) the requirements of section 25(2)(b) or (c) would have been satisfied, and child benefit would have been payable in respect of him continuously since the date of death of the late husband, had he not been absent from Northern Ireland and had a claim for child benefit been made in respect of him in the manner prescribed under the said Article 8; and".

Widowed Mother's Allowance in respect of deaths before 11th April 1988

- 3.—(1) Where a widowed mother's allowance is payable to a woman by virtue of regulation 16(1) of the principal regulations for a period which includes the whole or part of the week preceding 10th April 1988, or would have been so payable but for any of the provisions of the Social Security (Northern Ireland) Act 1975 mentioned in paragraph (2) below, the said regulation 16(1) shall apply to her as though regulation 2(6) above had not been made.
- (2) The provisions of the Social Security (Northern Ireland) Act 1975 mentioned in paragraph (1) above are the proviso to section 25(3)(b) (benefit not payable where a widow and a man to whom she is not married live together as husband and wife), section 82(5)(b) (benefit not payable while the person is imprisoned or detained in legal custody) and section 85(c) (overlapping benefits).

Savings

- 4. In the case of a woman whose husband died before 11th April 1988, the following provisions of the principal regulations, that is to say—
 - (a) regulation 11(1) and (3); and
 - (b) regulation 13(1) and (3),

shall continue to apply as though paragraph (4) or, as the case may be, paragraph (5) of regulation 2 above had not been made.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations correspond to provision contained in regulations made by the Secretary of State for Social Services in relation to Great Britain and accordingly, by virtue of section 10(2) of, and paragraph 21 of Schedule 3 to, the Social Security Act 1980 (c. 30) are not subject to the requirement of section 10(1) of that Act for prior reference to the Social Security Advisory Committee.

The regulations further amend the Social Security (Widow's Benefit and Retirement Pensions) Regulations (Northern Ireland) 1979 ("the principal regulations"). Minor amendments are made to regulations 5(1) and 7(b) of the principal regulations (regulation 2(2) and (3)). The age over which a widow is entitled to a Category C retirement pension and a benefit corresponding to a widow's pension is amended from 40 to 45 and the age under which a widow receives such a benefit at a reduced rate is amended from 50 to 55 (regulation 2(4) and (5)). Regulation 16 of the principal regulations is amended so that widows with children under 19 who are not receiving full-time education are no longer entitled to widowed mother's allowance (regulation 2(6)).

Regulation 3 contains different provisions for those women entitled to widowed mother's allowance by virtue of regulation 16 of the principal regulations where the date of death of the husband was before 11th April 1988.

Regulation 4 contains savings for existing beneficiaries of both Category C retirement pensions and benefit corresponding to widow's pension.
