- 1.—(1) This order may be cited as the Betting, Gaming, Lotteries and Amusements (1985 Order) (Commencement No. 2) Order (Northern Ireland) 1987.
- (2) In this order "the Order" means the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985.
