**Teachers' Superannuation (Amendment No. 2) Regulations
(Northern Ireland) 1987**

Made 3rd March 1987

Coming into operation 31st March 1987

The Department of Education in exercise of the powers conferred on it by Article 11(1) and (2) of and Schedule 3(2), (12) and (13) to the Superannuation (Northern Ireland) Order 1972(a) and of every other power enabling it in that behalf, and after consultation with representatives of education and library boards and of teachers and with such representatives of other persons likely to be affected by the regulations as appeared to it to be appropriate as required by Article 11(5) of the said Order, with the consent of the Department of Finance and Personnel(b), hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Teachers' Superannuation (Amendment No. 2) Regulations (Northern Ireland) 1987 and shall come into operation on 31st March 1987.

Interpretation

2. In these regulations—

- (a) "principal regulations" mean the Teachers' Superannuation Regulations (Northern Ireland) 1977(c);
- (b) "the Fund" means the Teachers' Superannuation Fund referred to in regulation 79 of the principal regulations;
- (c) "the superannuation account" means the Teachers' Superannuation Account referred to in regulation 80 of the principal regulations.

Abolition of the Fund

3. The Fund shall cease to exist and all its assets shall be paid to the Department and shall be treated as having been paid into the revenue of the Superannuation Account.

Amendment of principal regulations

4. The principal regulations shall be amended as follows—

- (a) regulation 79 shall be omitted;

- (b) regulations 80 to 92 shall be renumbered as regulations 79 to 91;
- (c) in regulation 81 paragraph (c) shall be omitted;
- (d) paragraphs (d), (e), (f) and (g) of regulation 81 shall be designated (c), (d), (e) and (f) respectively;
- (e) in Column A (Receipts) of Part I of Schedule 7 (Form of Account) Paragraph VII shall be omitted.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations abolish the Teachers' Superannuation Fund which was originally set up under the Teachers' Superannuation Act (Northern Ireland) 1926 as an amalgamation of the various funds then existing.

The Department of Finance and Personnel will transfer the assets of the Fund to the Department of Education which will credit them to the Teachers' Superannuation Account.
