**Foyle Area (Control of Netting) (Amendment)
Regulations 1988**

Made 20th May 1988

Coming into operation 19th June 1988

The Foyle Fisheries Commission, in exercise of its powers under section 13(1) of the Foyle Fisheries Act 1952(a) and section 13(1) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for the Marine in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Foyle Area (Control of Netting) (Amendment) Regulations 1988 and shall come into operation on 19th June 1988.

Amendment to the Foyle Area (Control of Netting) Regulations 1981

2. The Foyle Area (Control of Netting) Regulations 1981(e) shall be amended as follows:—

(a) In regulation 2 the following definitions shall be deleted:—

“braided”;

“multifilament yarn”; and

“twisted and plied”.

(b) For regulation 18 there shall be substituted:—

“18. A person shall not use for the purpose of taking or with intent to take salmon or trout in the Foyle Area any net, other than a landing net used solely as an auxiliary to lawful angling with rod and line, which contains any mesh made of a single filament of synthetic material.”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Foyle Area (Control of Netting) Regulations 1981 which control and restrict netting for salmon or trout in the Foyle Area.

They delete the definition of "braided", "multifilament yarn" and "twisted and plied". They also relax the further restrictions imposed on materials which may be used in the construction of commercial fishing nets for the capture of salmon or trout by Regulation 2(5) of the Foyle Area (Control of Netting) (Amendment) Regulations 1983.
