The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(2) of the Mental Health (Northern Ireland) Order 1986(a) and paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and all other powers enabling it in that behalf, hereby makes the following order:

Citation and interpretation

1.—(1) This Order may be cited as the Mental Health (1986 Order) (Commencement No. 3) Order (Northern Ireland) 1988.

(2) In this Order “the Order” means the Mental Health (Northern Ireland) Order 1986.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order brings into operation on 1st September 1988 the provisions of Article 115 of the Mental Health (Northern Ireland) Order 1986 which gives Health and Social Services Boards the power to appoint approved social workers with appropriate competence in dealing with mentally disordered persons.
