## VAUGHAN'S CHARITY

**The Vaughan's Charity (Administration) Order  
(Northern Ireland) 1988***Made* . . . . . 11th January 1988*Coming into operation* . . . . . 1st February 1988

WHEREAS under an Order dated 20th July 1973(a) made by the Ministry of Finance with the approval of the Attorney General under the Vaughan's Charity (Administration) Act (Northern Ireland) 1954(b) the Charity known as the Vaughan Agricultural Institute is administered in accordance with and subject to the provisions of the Scheme set out in the Schedule to that Order (hereinafter referred to as "the 1973 Scheme");

AND WHEREAS Article 30 of the 1973 Scheme provides that upon the application of the Trustees (they being defined in the 1973 Scheme and being hereinafter called "the Trustees") made with the approval of the Department of Agriculture the 1973 Scheme may be altered or amended by the Department of Finance and Personnel (hereinafter called "the Department") in such form and to such extent as may be approved by Her Majesty's Attorney General for Northern Ireland;

AND WHEREAS the Trustees with the approval of the Department of Agriculture have applied to the Department to amend the 1973 Scheme in manner hereinafter appearing;

AND WHEREAS the Attorney General has approved of such amendment being effected by an Order of the Department;

NOW THEREFORE the Department with the approval of the Attorney General hereby makes the following Order:—

1. This Order may be cited as the Vaughan's Charity (Administration) Order (Northern Ireland) 1988 and shall come into operation on 1st February 1988.

2. Article 25 of the 1973 Scheme is hereby revoked and the following Article is hereby substituted therefor—

"25. Full accounts shall be kept by the new trustees in proper books of account provided for the purpose in such form as may be approved by the Department. The accounts shall be audited by the Comptroller and

Auditor General, who shall furnish a copy of the accounts and his report thereon to the Department and the Department of Agriculture. Such fee, if any, as may be determined by the Department shall be paid in respect of the audit by the Comptroller and Auditor General.”.

EXPLANATORY NOTE

*(This note is not part of the Order  
but is intended to indicate its general purport.)*

Article 25 of the Scheme which governs the Vaughan's Charity provides that the accounts of the Charity shall be audited by auditors appointed by the trustees with the approval of the Department of Finance and Personnel and then examined by the Comptroller and Auditor General. This Order amends the Scheme by providing that the accounts shall be audited by the Comptroller and Auditor General only.
