## POLICE

**Royal Ulster Constabulary Pensions (Supplementary Provisions) (Amendment) Regulations 1988**

*Made* . . . . . 7th December 1988

*Coming into operation* . . . . . 1st January 1989

*To be laid before Parliament*

The Secretary of State, in pursuance of sections 10, 25 and 26 of the Police Act (Northern Ireland) 1970(a), and after consulting, in accordance with section 34(2) of the said Act of 1970, the Police Authority for Northern Ireland and the Police Association for Northern Ireland, and, in accordance with section 2(3) of the Police Negotiating Board Act 1980(b), the Police Negotiating Board for the United Kingdom, hereby, with the concurrence of the Treasury, makes the following regulations:—

*Citation and commencement*

1. These regulations may be cited as the Royal Ulster Constabulary Pensions (Supplementary Provisions) (Amendment) Regulations 1988 and shall come into operation on 1st January 1989.

*Interpretation*

2. In these regulations any reference to “the principal regulations” is a reference to the Royal Ulster Constabulary Pensions (Supplementary Provisions) Regulations 1988(c).

*Amendment of principal regulations*

3.—(1) In regulation 2 of the principal regulations after the words “in force shall” there shall be inserted the words “continue to”.

(2) For regulation 5 of the principal regulations there shall be substituted the following provision:—

*“Reserve (Pensions) Regulations*

5. The Royal Ulster Constabulary Reserve (Pensions) Regulations 1973(d) shall have effect subject to the amendments set out in Schedule 3 hereto.”

(3) For regulation 6 of the principal regulations there shall be substituted the following provision:—

(a) 1970 c. 9 (N.I.) as modified by S.I. 1973/2163 and S.I. 1981/1670

(b) 1980 c. 10

(c) S.R. 1988 No. 375

(d) S.R. & O. (N.I.) 1973 No. 314

*“Cadets (Pensions) Regulations*

6. The Police Cadets (Pensions) (No. 2) Regulations 1973(a) shall have effect subject to the amendments set out in Schedule 4 hereto.”.

(4) For Schedule 3 to the principal regulations there shall be substituted the Schedule set out in Schedule 1.

(5) For Schedule 4 to the principal regulations there shall be substituted the Schedule set out in Schedule 2.
