Births, Deaths and Marriages (Fees) Order
(Northern Ireland) 1989

Made 24th April 1989

Coming into operation 1st June 1989

*To be laid before Parliament under paragraph 3(3) of
Schedule 1 to the Northern Ireland Act 1974*

In exercise of the powers conferred upon me by section 1 of the Registration of Births, Deaths and Marriages (Fees, etc.) Act (Northern Ireland) 1955(a) as modified by section 40 of, and paragraph 4 of Schedule 5 to, the Northern Ireland Constitution Act 1973(b), Article 47 of the Births and Deaths Registration (Northern Ireland) Order 1976(c), Article 15 of the Financial Provisions (Northern Ireland) Order 1976(d) and section 9 of the Marriage Act 1983(e) I hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1989 and shall come into operation on 1st June 1989.

Fees payable

2. For the amounts of the fees payable under the several enactments set forth in column 2 of the Schedule in respect of the services described in column 3 and specified respectively in column 4, there shall be substituted the increased amounts specified respectively in column 5 thereof.

Revocation of Orders

3. The Marriages (Fees) Order (Northern Ireland) 1984(f) and the Births, Deaths and Marriages (Fees) Order (Northern Ireland) 1985(g) are hereby revoked.
