ROAD TRAFFIC AND VEHICLES

**Goods Vehicles (Certification) (Fees) (Amendment)
Regulations (Northern Ireland) 1989***Made* 23rd June 1989*Coming into operation* 7th August 1989

The Department of the Environment, in exercise of the powers conferred on it by Articles 54(1), 58(1) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf and with the approval of the Department of Finance and Personnel(b) as regards regulation 2, makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Goods Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1989 and shall come into operation on 7th August 1989.

Amendment of the 1982 Regulations

2. The Goods Vehicles (Certification) Regulations (Northern Ireland) 1982(c) are amended as follows—

(1) In regulation 8 (fees) for the Table substitute—

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Goods Vehicles (Certification) Regulations (Northern Ireland) 1982 by increasing—

(1) The fees payable on application or re-application for certificates for goods vehicles and trailers as follows:—

- (a) for vehicles not exceeding 1525 kilograms unladen weight from £13·20 to £14·30;
- (b) for vehicles exceeding 1525 kilograms unladen weight from £25·25 to £26·50;
- (c) for trailers from £14·00 to £14·50; and
- (d) where re-application is made within 21 days from a notice of refusal and the vehicle is presented for re-examination on a date arranged by the Department of the Environment—
 - (i) for vehicles not exceeding 1525 kilograms unladen weight from £6·60 to £7·15;
 - (ii) for vehicles exceeding 1525 kilograms unladen weight from £13·00 to £13·50; and
 - (iii) for trailers from £7·50 to £7·75 (regulation 2(1)).

(2) The fee payable on application for a duplicate certificate for a goods vehicle or trailer from £7·50 to £7·75 (regulation 2(2)).

The Goods Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1988 are revoked as a consequence of these Regulations.
