## ROAD TRAFFIC AND VEHICLES

**Large Private Passenger Vehicles (Certification)  
(Fees) (Amendment) Regulations (Northern Ireland) 1989**

*Made* . . . . . 23rd June 1989

*Coming into operation* . . . . . 7th August 1989

The Department of the Environment, in exercise of the powers conferred on it by Articles 67(3), 69 and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf and with the approval of the Department of Finance and Personnel(b) as regards regulation 2, makes the following Regulations:

*Citation and commencement*

1. These Regulations may be cited as the Large Private Passenger Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1989 and shall come into operation on 7th August 1989.

*Amendment of the 1982 Regulations*

2. For regulation 6 of the Large Private Passenger Vehicles (Certification) Regulations (Northern Ireland) 1982(c) substitute—

*“Fees*

6. The fee payable shall be—

- (a) £14·30 for inspection of a vehicle in accordance with regulation 3(3) or 5(3); and
- (b) £7·15 for re-inspection of a vehicle in accordance with regulation 5(4).”

*Revocation*

3. The Large Private Passenger Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1988(d) are revoked.

### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations further amend the Large Private Passenger Vehicles (Certification) Regulations (Northern Ireland) 1982 by increasing the fee payable—

- (a) from £13·20 to £14·30 on application or re-application (following refusal of a certificate) for inspection of a large private passenger vehicle; and
- (b) from £6·60 to £7·15 where a re-application is made within 21 days from the date of service of a notice of refusal and the vehicle is presented for re-inspection on a date appointed by the Department.

The Large Private Passenger Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1988 are revoked as a consequence of these Regulations.
