**Calf Premium (Protection of Payments) (Amendment)
Regulations (Northern Ireland) 1989**

Made 10th October 1989

Coming into operation 13th November 1989

The Department of Agriculture being a Department designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred on it by that section and of every other power enabling it in that behalf, hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Calf Premium (Protection of Payments) (Amendment) Regulations (Northern Ireland) 1989 and shall come into operation on 13th November 1989.

Amendment

2. The Calf Premium (Protection of Payments) Regulations (Northern Ireland) 1987(c) are hereby amended as follows:—

(a) in regulation 2—

(i) in the definition of “the Commission Regulation” after “21st April 1987” there shall be added “Commission Regulation (EEC) No. 4142/88 of 23rd December 1988(d) and Commission Regulation (EEC) No. 675/89 of 16th March 1989(e);” and

(ii) in the definition of “the Council Regulation” after “10th February 1987” there shall be added “and Council Regulation (EEC) No. 4132/88 of 20th December 1988(f) as amended by Council Regulation (EEC) No. 571/89 of 2nd March 1989(g);”

(b) for regulation 6(2)(a) there shall be substituted—

“may be accompanied by such other persons acting under his instructions as appear to him to be necessary to enable the identification, counting and verification of the total number of cattle; and”;

- (i) in paragraph 6 for the words "1st January 1989" there shall be substituted "3rd April 1989"; and
- (ii) in paragraph 7 after the words "Council Regulation (EEC) No. 467/87" there shall be added "and Council Regulation (EEC) No. 4132/88 as amended by Council Regulation (EEC) No. 571/89" and after the words "Commission Regulation (EEC) No. 1094/87" there shall be added "Commission Regulation (EEC) No. 4142/88 and Commission Regulation (EEC) No. 675/89".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Calf Premium (Protection of Payments) Regulations (Northern Ireland) 1987. They amend the definition of "Council Regulation" to include references to Regulation (EEC) No. 4132/88 and Regulation (EEC) No. 571/89 of the Council and they amend the definition of "Commission Regulation" to include references to Regulation (EEC) No. 4142/88 and Regulation (EEC) No. 675/89 of the Commission.

Council Regulation (EEC) No. 1346/86 now enables the payment of premiums for calves which are born in Northern Ireland on or after 28th April 1986 and before 3rd April 1989 which are reared in Northern Ireland to 6 months of age.

Commission Regulation (EEC) No. 1694/86 lays down more detailed rules for the granting of the premium in respect of calves born during this period. Copies of these Regulations are available for inspection at the Department's County Agricultural Executive Offices.

Finally, these regulations amend the declaration and claim on the application form for calf premium to take account of the amended Council and Commission Regulations.
