The Department of Agriculture, being a Department designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred upon it by that section and of every other power enabling it in that behalf, hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Sheep Annual Premium (Amendment) Regulations (Northern Ireland) 1989 and shall come into operation on 1st December 1989.

Interpretation

2. The Interpretation Act (Northern Ireland) 1954(c) shall apply to these Regulations as it applies to a Measure of the Northern Ireland Assembly.

Amendment of The Sheep Annual Premium Regulations (Northern Ireland) 1987

3. For regulation 4(2) of the Sheep Annual Premium Regulations (Northern Ireland) 1987(d) there shall be substituted—

"(2) An application for a premium in respect of a marketing year shall be delivered to the competent authority on or after 1st January in the calendar year in which the marketing year commences and not later than—

- (i) 10th April in that calendar year, or
- (ii) 9th April in that calendar year, if a leap year, or
- (iii) if 10th April or, in a leap year, 9th April in a Saturday, Sunday or public holiday, the next following working day.".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Sheep Annual Premium Regulations (Northern Ireland) 1987 ("the principal Regulations"). The principal Regulations implement Commission Regulation (EEC) No. 3007/84 as amended by Commission Regulation (EEC) No. 3378/85 which lays down detailed rules for the application for payment of a sheep annual premium to sheepmeat producers. The principal Regulations provide for two periods during which applications for premium in respect of a marketing year must reach the Department of Agriculture. The first period is between the 1st December and the 24th December in the marketing year preceding that for which the application is being made. The second application period is between the 1st January in the calendar year in which the marketing year commences and the 10th April of that calendar year.

These regulations remove the first application period.
