(Continuance) Order (Northern Ireland) 1990**

The Department of the Environment, in exercise of the powers conferred by Article 4(2)(a) of the Local Government (Temporary Provisions) (Northern Ireland) Order 1986(a) ("the 1986 Order"), read with paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of every other power enabling it in that behalf, hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Local Government (Temporary Provisions) (Continuance) Order (Northern Ireland) 1990 and shall come into operation on 30th May 1990.

*Continuation of Article 3 of the 1986 Order*

2. Article 3 of the 1986 Order shall continue in force until the expiry of 12th February 1991.

*Revocation*

3. The Local Government (Temporary Provisions) (Continuance) Order (Northern Ireland) 1988(c) and the Local Government (Temporary Provisions) (Continuance) Order (Northern Ireland) 1989(d) are hereby revoked.

## EXPLANATORY NOTE

*(This note is not part of the Order.)*

Article 3 of the Local Government (Temporary Provisions) (Northern Ireland) Order 1986 (the 1986 Order) enables the head of the Department of the Environment to make provision for the exercise of the functions of any district council in Northern Ireland, or of any joint committee appointed by two or more such councils, where the council or committee fails, or is unable or unwilling, to exercise any of its functions duly and effectually. Under Article 4 of the 1986 Order, Article 3 shall remain in force until 31st May 1988 unless continued in force by an Order under paragraph (2)(a) of that Article for a period not exceeding one year from the coming into operation of the Order. The Local Government (Temporary Provisions) (Continuance) Order (Northern Ireland) 1989 (S.R. 1989 No. 110) provides that Article 3 of the 1986 Order shall continue in force until the expiry of 29th May 1990.

This Order provides that Article 3 shall continue in force until the expiry of 12th February 1991, the date having effect under Article 4 of the 1986 Order for the final expiration of Article 3.
